OFFICIAL RULES

Last Updated and Effective as of December 1, 2020

These Sweepstakes, offered in part through the Celebrity Slots and/or Celebrity Slots & Sweepstakes mobile applications ("App", "Apps", "APP", "APPS", "GAME", "GAMES", "Game", "Games"), are governed by these official rules (the "Official Rules"), the Terms of Use located at <https://celebrityslots.com/terms-of-use> (the "Terms of Use"), the Privacy Policy located at <https://celebrityslots.com/privacy-policy> (the "Privacy Policy"), and the applicable "Sweepstakes Info Page" as displayed within the Apps, the contents of which is also available at <https://celebrityslots.com/sweepstakes> (website update in progress). The Terms of Use, Privacy Policy, Official Rules, and each Sweepstakes Info Page are collectively referred to herein as the "Sweepstakes Rules".

THE APPS ARE FREE TO PLAY.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN ANY SWEEPSTAKES.

BY PARTICIPATING IN ANY SWEEPSTAKES, YOU ACKNOWLEDGE, ACCEPT AND AGREE TO BE BOUND BY THESE OFFICIAL RULES AND THE SWEEPSTAKES RULES AND FURTHER REPRESENT, WARRANT, AND COVENANT THAT YOU: (A) HAVE THE FULL LEGAL RIGHT, ELIGIBILITY, AND AUTHORITY TO ENTER ANY WEEKLY SWEEPSTAKES; AND (B) WILL FULLY COMPLY WITH ALL APPLICABLE LAWS, REGULATIONS, STATUTES, AND ORDINANCES IN CONNECTION WITH ANY WEEKLY SWEEPSTAKES AND YOUR USE OF THE APP.

2. Eligibility: Each Sweepstakes is open only to legal residents of the 50 United States, the District of Columbia, or Puerto Rico, but excluding the State of Washington and any jurisdiction where any Sweepstakes is prohibited by law, who are at least eighteen (18) years of age or older or the age of majority in their state of residence (which is nineteen (19) in Alabama, Nebraska, twenty-one (21) in Mississippi, and eighteen (18) in all other states) as of the date of entry (each such person, an "Entrant"). Each Sweepstakes is entirely void in the State of Washington and likewise is void outside of the fifty (50) United States, the District of Columbia, or Puerto Rico, and wherever else prohibited, taxed or restricted by law. Officers, directors, managers, and employees of Sponsor, and each of its respective parents, subsidiaries, affiliates, partners, and related companies and their respective advertising and promotion agencies, consultants and agents, and any others engaged in the development, production, execution or distribution of these Sweepstakes (collectively "Sponsor Entities"), as well as the immediate family (spouse, parent(s), siblings, sister in-law or brother in-law, and children) and household members of any Sponsor Entities, are not eligible to enter or win any prizes in any Sweepstakes. Each Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Each Sweepstakes may only be entered in or from the fifty (50) United States (excluding the State of Washington), the District of Columbia, or Puerto Rico, and entries originating from any other jurisdiction are not eligible for entry. Each Entrant is responsible for checking the applicable laws in Entrant's jurisdiction before participating in any Sweepstakes to make sure that Entrant's participation is legal and to ensure that Entrant complies with all relevant laws. An Entrant may be required to provide proof of eligibility by way of valid identification (e.g., driver's license, passport, state identification card, or military identification card). Participation and/or entry in any Sweepstakes constitutes Entrant's full and unconditional agreement to the Sweepstakes Rules and Sponsor's decisions thereunder, which are final and binding in all matters related to any Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

3. Sweepstakes Period or Promotion Period: Each individual Sponsor's Sweepstakes Prize is one individual and separate Sweepstakes with its own corresponding Sweepstakes Period or Promotion Period; which may repeat daily, weekly, bi-weekly, monthly, bi-monthly, or quarterly as indicated by the Sponsor and/or Celebrity Slots through the App, the Sweepstakes info Page or otherwise through the Sponsor's Celebrity Slots website,

creating new individual and separate daily, weekly, bi-weekly, monthly, bi-monthly, or quarterly Sweepstakes for each Sweepstakes Prize/Period combination; or be a non-repeating Sweepstakes which has its own specified Sweepstakes Period or Promotion Period. All time calculations are Pacific Time and based on local time in Los Angeles, California.

- **Daily Sweepstakes Periods:** Each Daily Sweepstakes offered through the Apps is offered on a twenty-four (24) hour period starting at 12:00:01 AM (Pacific Time (PT)) and ending at 11:59:59 PM (PT) (each, a “Daily Promotion Period” or “Daily Sweepstakes Period”).
- **Weekly Sweepstakes Periods:** Each Weekly Sweepstakes offered through the Apps is offered on a seven (7) day period starting on Monday at 12:00:01 AM (Pacific Time (PT)) and ending at 11:59:59 PM (PT) on Sunday (each, a “Weekly Promotion Period” or “Weekly Sweepstakes Period”); except that the first day of the applicable Weekly Sweepstakes may not be a Monday.
- **Bi-Weekly Sweepstakes Periods:** Each Bi-Weekly Sweepstakes offered through the Apps is offered on a fourteen (14) day period starting Monday at 12:00:01 AM (Pacific Time (PT)) and ending at 11:59:59 PM (PT) on Sunday (each, a “Bi-Weekly Promotion Period” or “Bi-Weekly Sweepstakes Period”); except that the first day of applicable Bi-Weekly Sweepstakes may not be a Monday.
- **Monthly Sweepstakes Periods:** Each Monthly Sweepstakes offered through the Apps is offered on a calendar month starting on the first day of the applicable month at 12:00:01 AM (Pacific Time (PT)) and ending at 11:59:59 PM (PT) the last day of the month (each, a “Monthly Promotion Period” or “Monthly Sweepstakes Period”); except that the first day of applicable Monthly Sweepstakes may not be on the first day the applicable calendar month.
- **Bi-Monthly Sweepstakes Periods:** Each Bi-Monthly Sweepstakes offered through the Apps is offered for two (2) calendar months starting on the first day of the applicable month at 12:00:01 AM (Pacific Time (PT)) and ending at 11:59:59 PM (PT) the last day of the second month (each, a “Bi-Monthly Promotion Period” or “Bi-Monthly Sweepstakes Period”); except that the first day of applicable Bi-Monthly Sweepstakes may not be on the first day of the applicable calendar month.
- **Quarterly Sweepstakes Periods:** Each Quarterly Sweepstakes offered through the Apps is offered for a particular calendar year quarter starting on the first day of the applicable quarter (January 1st, April 1st, July 1st, or October 1st) at 12:00:01 AM (Pacific Time (PT)) and ending at 11:59:59 PM (PT) the last day of the applicable quarter (March 31st, June 30th, September 30th, or December 31st) (each, a “Quarterly Promotion Period” or “Quarterly Sweepstakes Period”); except that the first day of applicable Bi-Monthly Sweepstakes may not be on the first day the applicable calendar quarter.
- **Non-repeating Sweepstakes Periods:** Each non-repeating Sweepstakes offered through the Apps will have its own individual start date beginning at 12:00:01 AM (Pacific Time (PT)) on the applicable start date and ending at 11:59:59 PM (PT) on the applicable end date.

4. How to Enter: The Apps are free to play and there is no cost or payment required to enter or win any Sweepstakes and all entries have the same chance of winning. Your chance of winning without a purchase are the same as the chance of someone who buys something. It would be unlawful to give any advantage to buyers in a sweepstakes.

There are two (2) ways to enter a given Sweepstakes, App Entry and Mail-in Entry:

(a) App Entry: A person can participate in the Sweepstakes by downloading the App for free, registering via Facebook, Google or Apple and playing in the App's social, free to play, mobile slots machines or other available games. Each spin of the slots machine, regardless of bet, has a 1 in 4 chance of earning Sweepstakes entries. Increased bet amounts do not increase your chance of earning Sweepstakes entries or the number of Sweepstakes entries earned. A person can also participate in the Sweepstakes in the following way by playing games in the app, taking surveys, watching videos, or engaging in any other activities that Sponsor, its affiliates, or partners offer that provide for entry into the Sweepstakes. This Sweepstakes may be presented in conjunction with different offers sponsored or cosponsored by Sponsor, its affiliates, and partners, and may be presented in conjunction with offers sponsored by different organizations. Sweepstakes may be presented in different creative presentations by different organizations and under different creative titles.

Clicking through to any other linked pages, including sponsored advertisements, will not result in additional Sweepstakes entries.

The App is free to download, although carrier data rates may apply to the download and use of the App. You must enter a given Sweepstakes during the applicable Sweepstakes Period for that specific Sweepstakes to be eligible to win a prize for that Sweepstakes.

(b) Mail-In Entry: On a card that is no smaller than 3 ½ x 5 inches and no larger than 4 ¼ x 6 inches, legibly handwrite your complete name, full mailing address, email address, phone number, date of birth, customer ID and/or account #, and the specific Sweepstakes you want to enter, and enclose in an outer envelope with legible, handwritten and printed recipient and return addresses and mail with proper postage (metered mail not accepted) to: 2400 N. Lincoln Ave. Altadena, CA 91001 (each an "Entry Envelope").

All Entry Envelopes must be postmarked by and between the first day of the applicable Sweepstakes Period and received by the last day of the applicable Sweepstakes Period for the specific Sweepstakes you wish to enter.

There is a limit of one (1) write-in entry per envelope, but the number of Entry Envelopes which may be sent is unlimited. Each Entry Envelope properly received by Sponsor within the applicable Sweepstakes Period is equal to twenty (20) "raffle ticket" entries into the corresponding Sweepstakes only; such "raffle ticket" entries do not apply, count toward, or carry over to any other Sweepstakes. Multiple entries submitted or completed by anyone other than the Entrant are void. No mechanical reproductions will be accepted. Any mail-in entry and Entry Envelope not conforming to the requirements of this section are void and will not be eligible to win any Prize(s).

Multiple Entrants are not permitted to share the same email address. Any attempt by an Entrant to obtain more than that number of entries stated above, including without limitation by using multiple/different email addresses, identities, registrations and logins, or any other fraudulent, deceptive or other method(s), will void all of that Entrant's entries and that Entrant may be disqualified. Sponsor or Celebrity Slots reserves the right to disqualify Entrants at its sole discretion for any actual or suspected violation of the Sweepstakes Rules. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration or entry based on an email address (if applicable), the authorized account holder of the email address used to register or enter will be deemed to be the registrant or Entrant, as the case may be. The "authorized account holder" is the natural person assigned an email address by an Internet access provider,

online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being the authorized account holder. It is solely the responsibility of the Entrant to notify Sponsor in writing if the Entrant changes his or her email address during any Sweepstakes Period.

Neither Sponsor nor any Sponsor Entities or Celebrity Slots are responsible for entries which are lost, late, illegible, stolen, mutilated, incomplete, invalid, postage-due, misdirected or undeliverable, whether due to system errors, omissions, interruption, deletions, defects, delay in operations, theft, destruction, or failures, faulty transmissions or other telecommunications malfunctions, human error, entries not received resulting from any hardware, software or network failures of any kind, or otherwise. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsor or any Sweepstakes Entities.

5. Winner Selection and Odds: For the Sweepstakes: On or about forty-eight (48) hours after each Sweepstakes Period or Promotion Period, potential Prize winners for the corresponding Sweepstakes will be selected in a random drawing by the Sponsor's computer system from all eligible entries received by Sponsor in accordance with these Official Rules. Odds of winning a prize depend on the number of eligible entries received for a given Sweepstakes. By entering any Sweepstakes, Entrants unconditionally and completely agree to be bound by the Sweepstakes Rules and further that Sponsor's decisions as to the administration and operation of any Sweepstakes and the selection of the potential winners are final, non-appealable, and binding in all matters related to any Sweepstakes. Sponsor will determine the potential Sweepstakes winners from all eligible entries received during the applicable Sweepstakes Period, and Sponsor's decisions shall be final. For the Sweepstakes Instant Win Game: Sponsor's computer systems will randomly select potential Sweepstakes Instant Win times during the promotional period and Prizes will be randomly assigned to the Sweepstakes Instant Win times. If you are the first player to play the applicable Game at or after one of the randomly generated times, you will be a potential instant winner of the Prize indicated.

6. Winner Notification: Sponsor will attempt to complete a random drawing within ten (10) business days of the end of the Sweepstakes Period to select one (1) potential prize winner for the Sweepstakes from among all eligible entries received for that drawing. The random drawing will be conducted by, or under the supervision of, the Sponsor. The odds of winning this Sweepstakes depend on the number of eligible entries received for the drawing. Potential winners notified through the App will be required to follow the instructions provided via the in-App notification to claim each eligible prize and for certain prizes may also be required to provide (through the App) a valid email address, to which a subsequent notification email will be sent providing further instructions concerning the process by which the potential winner may claim the applicable prize. If a potential winner is required by any applicable law to comply with certain conditions or requirements in order to be eligible to receive the prize, the potential winner will be required to fully comply with such requirements.

7. Prizes and Prize Restrictions:

(a) Virtual Prizes: Virtual Prizes may be made available digitally within the Apps only, are not real money and do not have any monetary value in the App or outside the App and cannot be traded or bartered for anything of value.

a. - Meet & Greet (In Person)
- Meet & Greet (In Person) with Dinner

- Meet & Greet (Virtual) with Dinner
- Meet & Greet (Virtual) with Gift Card
- Personalized Video Message
- Subscription
- Tickets (event)
- Other prizes as noted

b. Real World Prizes are taxable in the United States as ordinary income to the winner thereof, who is solely responsible for the payment of all taxes levied, including, but not limited to federal, state and local income and/or gift taxes. The potential winner will also be required to complete and return the Required Documents (as set forth in Section 8 below) in order to become a winner (“Winner”) of any Real World Prize. Winner must accept any prize “as-is” as described by Sponsor in these Official Rules. If Winner does not claim the prize within the applicable time period and return the Required Documents as described in Section 8 below, the prize may be forfeited and Sponsor may in its discretion select another potential winner who will be subject to the same requirements in order to be deemed the Winner. Prizes are non-transferable and no substitution will be made except as provided herein, at the Sponsor’s sole discretion. Unclaimed prizes will not be awarded. If a prize, or any portion thereof, cannot be awarded for any reason, Sponsor reserves the right to substitute a prize (or a component thereof) for one of equal or greater value if the designated prize should become unavailable for any reason. All unspecified costs and expenses associated with the acceptance or use of a prize are the sole responsibility of winner. 8. Winner Requirements and Confirmation Process: IN ALL CASES, AWARD OF A PRIZE IS SUBJECT TO CONFIRMATION / VERIFICATION BY SPONSOR AND/OR CELEBRITY SLOTS AND IS CONTINGENT UPON COMPLIANCE WITH THESE OFFICAL RULES.

An Entrant is not a winner of a prize, even if the Sweepstakes or Sweepstakes Instant Win Game should so indicate, unless and until Entrant’s eligibility and the potential winner play/entry has been verified and Entrant has been notified that verification is complete.

- Relevant contact information including but not limited to full name, date of birth, email address, phone #, account / customer ID.

You and/or the potential winner(s) In may not be listed on any United States Government list of prohibited or restricted parties. You and/or the potential winner(s) also must be able to represent and warrant that you are not subject to backup withholding tax because you are exempt from backup withholding or because you have not been notified by the Internal Revenue Service (IRS) that you are subject to backup withholding as a result of failure to report all interest or dividends, or because the IRS has notified you that you are no longer subject to backup withholding. Sponsor and/or Celebrity Slots is required by law to report all Prizes paid out and will provide a 1099 Misc. at the end of the year to you detailing what Prizes were awarded to you to the IRS.

Refusal to return legible, completed, and executed (where applicable) versions of any of the Requested Documents, within the time period instructed by Sponsor or Celebrity Slots, not to exceed 30 days, including but not limited to the completed/executed IRS W9 Tax Form upon Sponsor and/or Celebrity Slots request, may result in forfeiture of the applicable Prize(s) with such refusal resulting in the possible cancellation of account and prohibition of future use of the Apps.

Sponsor and Celebrity Slots strongly advises that prize winners consult with their accountant or other tax professional as to whether (and, if so, to what extent) prize monies may be tax-deductible. SPONSOR AND CELEBRITY SLOTS MAKES NO REPRESENTATION, GUARANTEE OR WARRANTY OF ANY KIND THAT PRIZE MONIES ARE TAX-DEDUCTIBLE OR ELIGIBLE FOR OTHER FAVORABLE TAX TREATMENT.

All unspecified expenses in conjunction with Prize(s) claim (e.g., bank fees if payment via ACH is selected; fees imposed by PayPal if such payment method is selected), prize acceptance and use are the winner's sole responsibility. Prizes are not transferable.

Pending a positive outcome of the confirmation process, a Celebrity Slots, LLC or Sponsor representative will notify the potential winner via email and/or phone. The potential winner must respond within the time period designated in the notification, or Celebrity Slots, LLC or Sponsor may move on to another randomly drawn potential winner.

A potential winner, and if applicable, their guest(s) must deliver the Required Documents to Sponsor or Celebrity Slots in the manner and within the time period instructed by Sponsor, not to exceed 30 days. If the potential winner cannot be contacted, fails to execute and return the Required Documents as instructed by Sponsor or Celebrity Slots, fails to comply with these Official Rules, or the prize is returned as undeliverable, then such potential winner forfeits the prize. In the event that the potential winner is disqualified for any reason, Sponsor or Celebrity Slots may award the Prize(s) to an alternate potential winner in Sponsor's or Celebrity Slot's sole discretion. Winner will indemnify Sponsor, Sponsor Entities, Celebrity Slots and any licensee of Sponsor or Celebrity Slots against all claims, damages, liabilities, and expenses (including reasonable counsel fees and legal expenses) arising out of any breach of these terms by Winner. Winner agrees that nothing in these Official Rules grants Winner a right or license to use Sponsor's, Sponsor Entities', or Celebrity Slots name(s) or any trademark(s) or service mark(s).

Where applicable, the prize will be shipped to the physical address or sent to the email address provided in the Required Documents within 4 to 6 weeks from receipt of the fully completed and verified Required Documents. If the email address provided in the Required Documents is different than the email address supplied at the time of entry via their account login, Sponsor or Celebrity Slots retains the right to disqualify the winner. In the event the prize is returned, the address is insufficient or incomplete for shipping or emailing purposes, or undeliverable for any reason, the prize winner will be disqualified and an alternate prize winner will be selected from the remaining eligible entries received. If the alternate prize winner's prize is returned, the address is insufficient or incomplete for shipping or emailing purposes, or undeliverable for any reason, the alternate prize winner will be disqualified and the prize will not be awarded.

No compensation will be provided for any prizes that are not able to be awarded to a prize winner.

9. Publicity: Acceptance of any prize shall constitute and signify each Winner's agreement and consent that Sponsor may use such Winner's name, city and state of residence, likeness, photograph, statements, video recordings, audio recordings, and/or prize information, for any lawful purpose, worldwide, in any media now known or hereafter developed, including the Internet, in perpetuity, without limitation and without further payment or consideration, except where prohibited by law. Unless prohibited by law, the Winner hereby agrees to participate in public relations activities as reasonably requested by Sponsor. Notwithstanding anything to the contrary herein, State of Tennessee residents will not be required to sign any Publicity Release as a condition of winning a prize.

10. Release of Liability: By entering any Sweepstakes and/or receiving any prize, each Entrant (including all potential winners and all applicable Winner(s)) hereby release and waive, and further agree to indemnify and hold harmless, Sponsor and all Sponsor Entities (collectively, the "Released Parties"), from and against, any controversy, demand, right, obligation, liability, claim, action or cause of action, of every kind and nature, including, but not limited to personal injury, death, or damage to or loss of property, arising out of participation in any Sweepstakes or any Sweepstakes-related activity, or receipt, possession or use or misuse of any prize, and for any claims based on publicity rights, defamation, invasion of privacy, copyright infringement, trademark infringement or any other intellectual property-related cause of action. Sponsor is not responsible if any Sweepstakes cannot take place or if any prizes cannot be awarded due to cancellations, delays or interruptions due to acts of God, acts of war, natural disasters, weather, acts of terrorism or any other cause outside Sponsor's reasonable control. Entrants who do not comply with these Official Rules, or attempt to interfere with any Sweepstakes in any way, shall be disqualified.
